Plenary Session, 14TH of December 2023



On December 14, 2023, the High Prosecutorial Council convened in its next plenary meeting. The meeting took place under the leadership of the Vice-Chairman of the Council, Mr. Tartar Bazaj and in the absence of the head of the Council, Mr. Alfred Balla and Mr. Sokol Stojani. Also, as always, representatives from OPDAT and EU4JUSTICE were present. The meeting started with the approval of the two minutes of the Plenary Sessions dated 13.11.2023 and 30.11.2023. Subsequently, the following decisions were adopted:

1. The appointment of prosecutor Ervisa Hyka to the position of assistant magistrate in the General Prosecutor's Office;
 2. The appointment of the Rapporteur and the Legal Advisor responsible for the evaluation of the candidates who have re-candidated for the position of the head of the prosecutions at the Courts of First Instance of the General Jurisdiction of Elbasan and Durrës and at the prosecution at the Court of Appeal of the General Jurisdiction. After the draw it resulted for:
 - a. Prosecutor Anita Jella, Relator Mr. Zeqir Hoda, Legal Advisor Olger Rumnici;
 - b. Prosecutor Genti Xholi, Relator Ms. Ledina Riza, Legal Advisor Andi Pogaçe;
 - c. Prosecutor Kreshnik Ajazi, Relator Ms. Nurihan Seiti, Legal Advisor Armida Moçka.
- Suspension of the ethical and professional assessment procedure for prosecutor Mustafa Turku and Moisi Duda;
- Completion of the ethical and professional evaluation procedure without a final decision, for prosecutor Përparim Vukaj;
- Verification of the assets and image of the candidate for the Initial Training Program of the School of Magistrates in the academic year 2023-2024, Mr. Ervin Zoto and the approval of the partial list of candidates for students in the School of Magistrates for the academic year 2023-2024;
- The replacement of Mr. Artur Cara, with Mr. Ylli Pjeternikaj, as the Legal Advisor responsible for the assessment;
- Approval of the temporary appointment of Mrs. Enkeleda Hoxha, prosecutor in the Prosecutor's Office at the First Instance' s Court of the General Jurisdiction of Kukës, to exercise the function of the head of this prosecution for a period of three months;

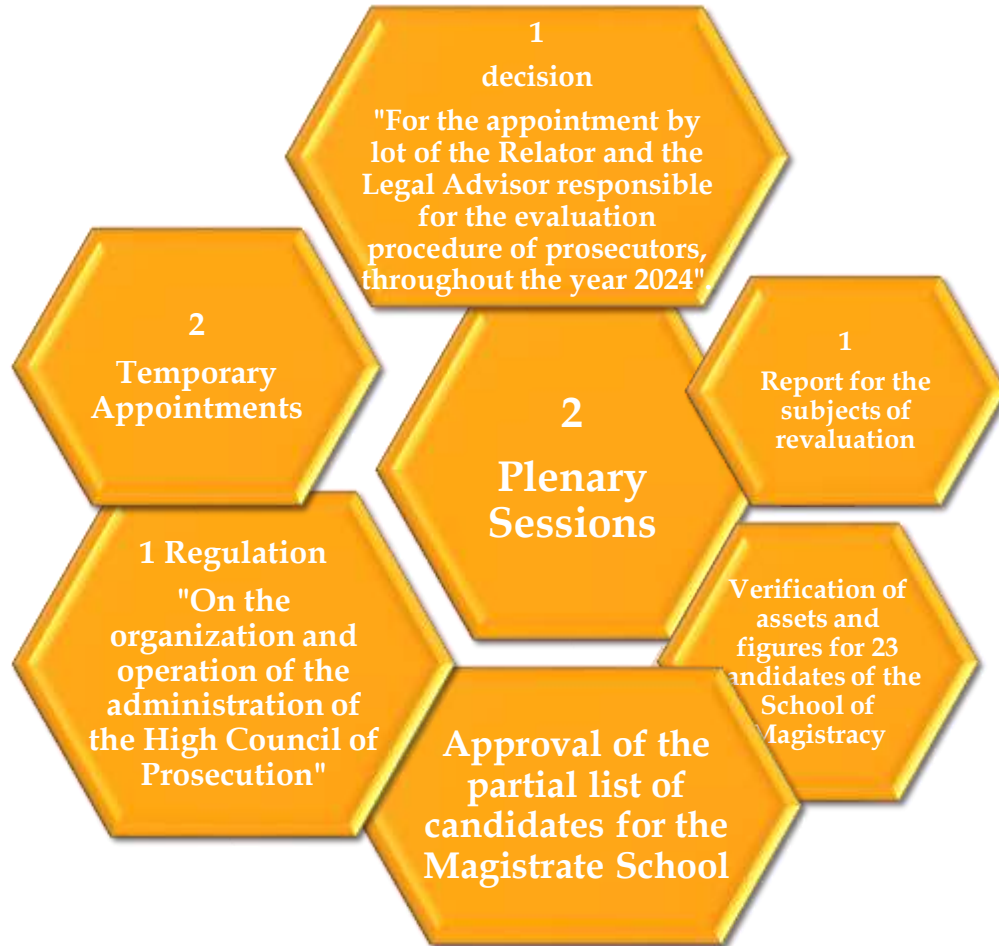

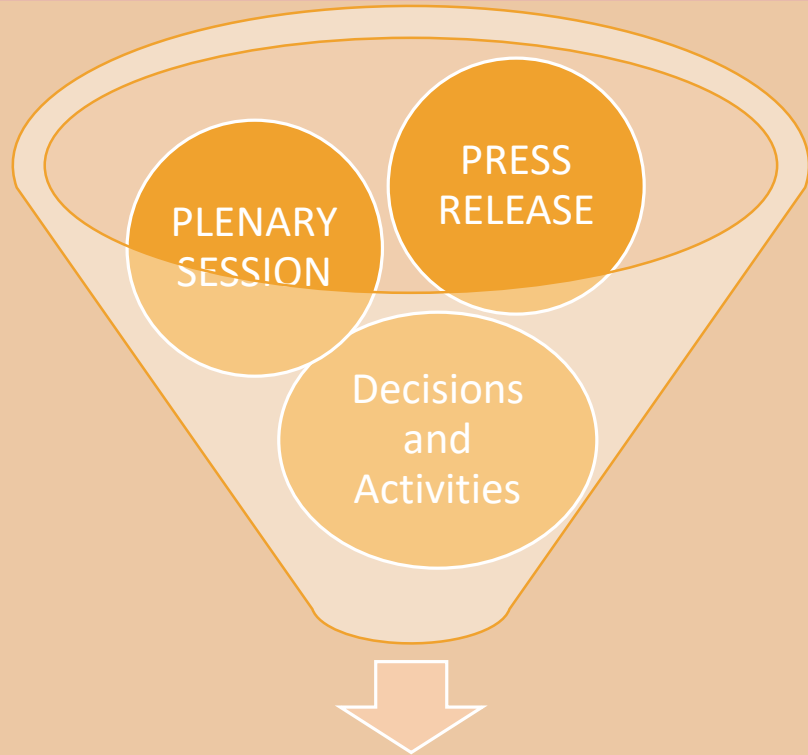

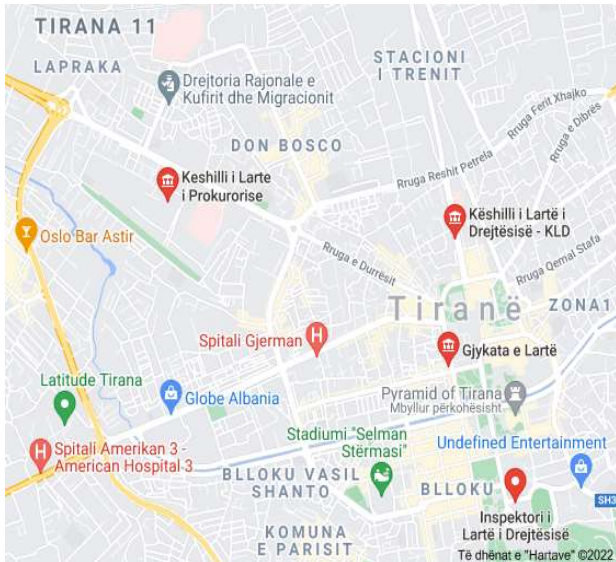
